



# Can I install photovoltaic panels on my house for free

Are solar panels free?

The Department of Energy is aware of claims of offers for free solar panels or that solar companies must provide solar panels for free if requested. However, the federal government does not offer any programs for free home solar panel installations nor does the government require companies to grant solar panels for free to customers.

Do low-income solar programs offer free solar panels?

Low-income solar programs don't typically provide completely free solar panels, but they can greatly reduce installation costs. Most of the programs provide rebates or grants to cover the majority of rooftop solar installation costs for qualified applicants, but there may still be some costs or payments required.

Does the federal government offer free solar panels?

The federal government does not provide free solar panels, but does provide incentives that reduce the cost of going solar. You can go solar with no upfront cost by taking out a \$0-down loan, signing a lease or PPA, or subscribing to a community solar farm. Of the no upfront cost solutions, \$0-down loans provide the best long-term savings.

Are free solar panels a lie?

While the word "free" implies there are no associated costs, this is not usually the case with free solar panel offers. "I have never seen an advertisement offering free solar that is not a lie," said Neil Gallagher of Brighterway Solar, a solar installation company in Florida.

Can you get a tax credit if you buy solar panels?

"The federal government does not have any programs that install solar panels on the homes of Americans for free," Jones-Albertus wrote. "A 30% tax credit is available to those who purchase a solar energy system."

Do you own solar panels with a "no cost solar" agreement?

You will not own the solar panels with one of these "no cost solar" agreements. In other words, solar leases are essentially like renting solar panels. The solar company handles all of the installation and maintenance for a specified term, which is usually around 20 to 25 years.
