## the requirements for panel installation

What are the requirements for a solar photovoltaic (PV) panel?

4.6.1 Solar photovoltaic (PV) panels supported by framing that have sufficient uniformly distributed and unobstructed openings throughout the top of the array (horizontal plane) to allow heat and gases to escape, as determined by the enforcing agency, are generally not subject to this requirement (CBC Section 903.3.3).

Do you need a permit to install solar panels?

Generally,local governments require a homeowner's solar installer/contractor to obtain a permitfor rooftop panels before they can be installed. After the PV system is installed, a professional from the local government will inspect the new array to ensure all building, electrical, and safety codes have been followed.

Do solar PV installations need local government approval?

All solar PV installations need the local utility's approval link into the electricity grid, a process commonly referred to as "interconnection." This interconnection approval must be granted before a solar PV installation is allowed to operate and is completely separate from local government approval for the solar installation.

What are the requirements for solar PV installations in California?

Specific areas within Title 24 identify certain requirements for solar PV installations such as the California Electrical Code, California Building Code, California Plumbing Code, California Mechanical Code and California Residential Code (which applies to residential buildings of one or two units).

Do solar PV panels comply with fire/roof classification requirements?

4.1.1.3 Solar PV panels installed as a part of a building's roof structure: Solar PV panels installed as integrated roofing material shall complywith the minimum fire/roof classification requirements for roof covering as required by the current CRC Section R902.

What should be included in a solar PV installation checklist?

The checklist does not need to take the exact form of this template,but it should include the basic informationan installer,developer,or property owner would need to know in order to receive approval for the installation of a residential solar PV system.
